The Council of the Village of Poland Ohio met in REGULAR SESSION at the Poland Village Town Hall, 308 South Main Street, Poland, Ohio 44514-2082 on *Tuesday, March 7, 2017.* 

Poland Village Mayor Tim Sicafuse called caucus to order at 7:00 p.m.

Mayor Sicafuse introduced Gary Diorio, MS Consultants. Mr. Diorio discussed the following:

- 1. There is a grant available to replace traffic signals through the Eastgate Regional Council of Governments.
- 2. It is an 80/20 split through ODOT. The 20% share will come from the Village.
- 3. A letter of intent is needed from the Village and submitted to Eastgate by April 3, 2017.
- 4. The money will be available starting in four years State of Ohio fiscal year starting July 1, 2021.
- 5. Grant includes replacement poles, signal with LED lighting, video cameras, pedestrian heads, and mast arms for the signal. Mr. Diorio stated that he may be able to work in some decorative fluted poles as part of the grant.
- 6. He estimated that eight lights would cost approximately \$800,000 with the Village's share at \$160,000.
- 7. The main application is due by June 5, 2017. It will be completed by MS Consultants as part of the annual service contract with the Village.
- 8. Scoring is based on congestion management and improving the level of service regarding traffic flow. The congestion management analysis will be completed by MS Consultants.
- 9. The more local share provided the higher number of points earned towards the grant. For instance, a 20% match would give the Village no points but with a higher than 40% match, the Village would receive five points. Point values increase by one for each 5% increment in contribution (20-25% 1 point, 26%-30% 2 points, 31%-35% 3 points, 36%-40% 4 points. 41% or higher 5 points).
- 10. Mr Diorio suggested that road levy revenue could be used as the Village's contribution for the traffic light replacement. Atty. Macejko will research this question.
- 11. Mr. Dunnavant stated that the Streets and Finance committees could review this grant information and make a recommendation at the next council meeting. Mr. Srnec stated that the current budget includes the loop at State Route 170 and Johnson Place and replacement bulbs. The current traffic lights don't allow for the use of LED bulbs due to their electrical configuration.
- 12. Mrs. Wilson asked if traffic has been assessed lately. Chief Beatty stated that a traffic volume assessment has not been lately but the Street department is constantly adjusting traffic lights to accommodate traffic. A new system in the Village will synchronize traffic lights throughout the Village.
- 13. Chief Beatty mentioned that the box replacement at Johnson Place cost \$6,500. Mr. Diorio noted that a basic intersection change costs around \$70,000 today. Chief Beatty noted how expensive the box replacement would be at the intersection of Routes 224 and 170.
- 14. Mr. Diorio stated that there is another program available should the Village be unsuccessful with the ODOT grant through the CMAC (Congestion Mitigation Air Quality) program. It is also through ODOT and is called "STIP" or the "Statewide Transportation Improvement Program." It is the same 80/20 funding with it being available in four to five years. Chief Beatty noted that the State

of Ohio completed the replacement of all traffic lights in the unincorporated areas such as Boardman and Poland townships.

- 15. A discussion was held on the upcoming road project. Mr. Diorio stated that bids could be requested on the 2017 project in April or May. A stipulation could be written into the contract with the contractor that all repaying needs to be completed between July 15<sup>th</sup> and August 15<sup>th</sup> with the additional stipulation that the balance of the contract would be received after the October tax settlement. Mr. Diorio noted that the current cost for repaying one mile of road is \$150,000.
- 16. Mr. Dunnavant noted that the Streets committee will make a motion at the next meeting to start the process of applying for the traffic light grant. Mr. Diorio stated that he would start working on the Village's application.

Poland Village Mayor Tim Sicafuse called the REGULAR MEETING to order at 7:30 p.m. Poland Village Mayor Tim Sicafuse opened the meeting with the Pledge of Allegiance.

She noted that there are rumors circulating that the board plans to start logging the forest and there were many individuals at the meeting that had knowledge of the plan contents or hadn't looked at it at all. Mark Thompson stated that there seems to be a large misrepresentation about the plan and in many cases it was not read. Mrs. Wilson asked Mrs. Zedaker if she has had any one on one conversation yet with board members to get their thoughts on the forest management plan. Mrs. Zedaker stated that she has not. Mrs. Wilson asked if consideration was given to surveying residents on their thoughts about the forest. Mrs. Zedaker stated that it is hard to compile and tabulate the results of a survey based on her past experience and would welcome any suggestions from Council on what to use and how to go about accomplishing this recommendation.

She noted that of particular concern was the Bluebell Trail area and specifically with issues of dead and broken trees near the walking paths and the creek. She suggested that a compromised plan be developed to satisfy all interested parties.

#### 16. New Business - NONE.

- 17. **Old Business** Mr. Dunnavant discussed the Village's responsibility for the forest. It was discussed at the Forest Board meeting that there are hazards in the forest that are a liability to the Village. Rick Miller, forester, and an attorney attending the meeting both thought that signage be put up stating "Enter at your own risk" or "Village not responsible for damages or injury". Mr. Dunnavant asked Atty. Macejko to review the following:
  - i. The negligence issue as it relates to the Village's responsibility.
  - ii. Do signs negate the liability?
  - iii. What is the proper verbiage to use on the signage?

Mr. Dunnavant also noted that forest maintenance is needed. The trail footings are hazardous with the grindings being used washing away. He also noted that the bridge needs painted and the issues with the creek. Mr. Dunnavant noted that there is no funding available from the Village's budget to complete this work and suggested that Ordinance No. 1062.03 be reviewed to discuss taxpayer burden on the forest. He suggested that the Legislative committee review the ordinance and asked Council to consider a ¼ mill levy specifically for the forest. Mr. Srnec estimated that the levy would generate \$14,250 less \$2,000 in fees which would leave \$12,250 available for forest maintenance/projects. He thought it would possibly cost the average homeowner \$10 a year based on a \$100,000 home value for this millage. Mrs. Srnec noted that it's hard to always go to the residents for additional funding but she was in support of it. She stated that Council should put the levy request to the residents and find out if it is supported. Mr. Dunnavant further stated that the current forest ordinance allows for advisory committees for specific projects but this needs revised as well as it is very restrictive.

- b. Mrs. Srnec stated that she and Mr. Srnec had found and read the minutes from prior Forest Board meetings when Mrs. Butler was on the board. She noted that they found that Mrs. Butler supported the logging of the forest to pay for forest projects.
- c. Mark Thompson, 24 College Street, stated that the Forest Foundation was set up to fund the forest with its day to day activities. He noted that the foundation hasn't been doing that. The foundation will look for funding. In addition, the Forest Board will also work on obtaining funding for identified forest projects via donations from the community. Mr. Thompson congratulated Mr. and Mrs. Srnec on doing their homework with regards to finding the old Forest Board minutes.
- d. Elinor Zedaker, 70 Poland Manor, stated that the ordinance also states that the Forest Board should have a forester as a board member. She requested that prior to making any changes to the current ordinance that Council has a discussion with the Forest Board.
